- For combinations, order DOES NOT MATTER.
- <u>Combinations of *n* Objects</u> The number of ways of choosing *r* objects from *n* distinct objects is given by $C(n,r) = \frac{n!}{r!(n-r)!}$.
- In the notation C(n,r), the C stands for combination, the n is the number of objects that you are starting with, and the r is the number of those objects that you are choosing to be in a subset.
- The *nPr* command can be found in the calculator by pressing <u>MATH</u>, arrowing over to PRB, and selecting option #2.




