Course Description

Graphs are used to model problems in different areas in mathematics and engineering, such as in metric geometry, network theory, and VLSI design. This course will address algorithmic problems about graphs, such as how to efficiently determine whether the input graph has certain properties or efficiently find certain substructures in the input graph. We will cover classical results and recent developments.

Upon successful completion of this course, students will be ready and have the abilities to conduct research related to the algorithmic aspect of graph theory and explore applications.

Grading Policy

• Homework (50%): There will be one assignment in this semester. Due dates will be announced when dates approach. All work should be submitted to Gradescope. Problem sheets of homework will be available in Gradescope and will be frequently updated before the due dates



to include new questions related to materials covered in lectures. Announcements will be made when no more questions will be added. Collaboration for homework is allowed, but each student should write down his/her own solution and submit his/her own copy.

- Final project (50%): Present one research paper related to graph algorithms (broadly defined) orally and submit a written summary for the oral presentation. Students are expected to form groups with one or more people for this project. The maximum group size and the length of oral presentations will be decided based on the number of enrolled students. Each group makes one oral presentation, and each student submits his/her own written summary. The instructor will provide a list of papers, but students are welcomed to choose papers related to their research, as long as those papers are related to graph algorithms. Students who choose papers not in the list should consult with the instructor to obtain an approval. More details will be announced when the date approaches.
- For the final semester grade, students who get 90%-100% of points will be an A, 80%-90% of points will be a B, 70%-80% of points will be a C, 60%-70% of points will be a D, and an F for otherwise.

Late Work Policy

- No submission will be accepted after the deadline, except for university approved excuses.

- Week 1-5: Introduction, greedy algorithms, matching algorithms, shortest paths, Chinese Postman Problem, Travelling Salesman Problem.
- Week 6-8: Flows and cuts, multi-commodity flows, Gomory-Hu trees, edge-connectivity, 2-Disjoint Path Problem.
- Week 9-11: Fixed-parameter tractability, kernelization, tree-width, meta-theorems, graph minors, k-Disjoint Path Problem.
- Week 12-13: Algorithmic Lovasz Local Lemma, regularity lemma, property testing.
- Week 14-15: Project presentations.
